1. Welcome & Opening Prayer Craig Curtis welcomed delegates to the 2024 Conference Business Meeting.

2. Credentialing of Conference Delegates:

The District has also hired James Mendoz and Joel Walters as regional directors and Samuel Placencio as associate director of Hispanic ministries.

7. Financial Reports & Approval Of 2024 Proposed Budget

### a. 2023 Financial Report

The Treasurer's Report was presented by Brent Burckart and Kevin Hammond. Brent reviewed the changes made at last year's Conference that impacted 2023's results. He highlighted the difference between the District's General Fund and the Strategic Savings fund. Kevin then reported on the year end (2023) Cash Balances and emphasized the funds held for church planters, leaving available cash of \$1,208,882. Brent outlined the proposed budget with its 4% reduction in spending.
